A MESSAGE FROM THE CHAIRMAN

Greetings,

The Buffalo Water Board is excited to invite you to the inaugural FLOW Up Summit 2024. This two-day collaborative meeting gathers several Upstate New York representatives for workshops, discussions, and strategic planning for lead service line remediation. This summit exclusively invites executives and leaders from sectors such as municipal water, city government, public health, and MWBE/SDVB specialists and construction trades labor leaders.

Several years ago, we determined that to have any chance of replacing LSLs at scale, Buffalo Water would need to develop a more intimate relationship with customers to gain access to tens of thousands of private homes. Since then, we have partnered with local community groups and healthcare professionals for a boots-on-the-ground approach utilizing the community's most trusted organizations to help increase public awareness and cooperation. However, much more needs to happen for this project to be successful.

The EPA's new Lead Copper Rule Improvements (LCRI) challenge cities nationwide to replace all lead service lines within ten years. Like Buffalo, many Upstate NY cities do not have the funding or resources to complete the job. The FLOW Up Summit's objective is to develop strategies that will help drive state funding toward Upstate NY cities and generate ideas to improve upstate economies through equitable workforce development practices.

We believe our unified efforts will build a 'best practices' roadmap for Albany lawmakers. We invite you to join us as we push for LSL replacement progress for all Upstate New York cities.



Join our coalition of local government leaders, public health professionals, and water service providers as we build strategies that send state funding upstate to replace old lead service lines.



BACKGROUND THE LEAD AND COPPER RULE

The U.S. Environmental Protection Agency (EPA) recently announced a new rule for the Lead and Copper Rule Improvements (LCRI), which officially mandates that all lead service lines (LSL) be replaced within ten years. Despite its righteous intent to protect public health, the new rule significantly accelerates the deadline to complete an enormous workload for many communities and simultaneously creates a tremendous financial burden on municipal water service providers nationwide and their customers.

The rule does not require water providers to pay for private LSL replacements, but most working-class customers cannot afford the added expense. Some municipalities have been able to replace LSLs at no cost to customers through relief or grant funding. However, in old cities with thousands of lead service lines, costs can be tens to hundreds of millions, which will burden water service providers and their customers far beyond any other regulation or investment.

UPSTATE MUNICIPALITIES MUST UNITE TO FLOW EFC FUNDING UPSTATE

August 22, 2024 press release:

"Governor Kathy Hochul today announced the New York State Environmental Facilities Corporation (EFC) Board of Directors approved \$265 million in financial assistance for water infrastructure improvement projects across the state. The Board's approval authorizes municipal access to low-cost financing and grants to get shovels in the ground for critical water and sewer infrastructure projects. Of the project funding approved today, \$30 million in grants from the federal Bipartisan Infrastructure Law (BIL) will help 30 communities across the state to inventory lead service lines in drinking water systems, a vital first step for starting replacement projects and protecting public health" The Board approved grants and financings to local governments from BIL, the Clean Water and Drinking Water State Revolving Funds (CWSRF and DWSRF), and grants already announced pursuant to the Water Infrastructure Improvement (WIIA) program. Leveraging BIL funding with the State's investments will continue to empower local communities to make critical system improvements to safeguard public health, protect the environment, bolster communities' climate readiness, and promote economic development."

LEAD SERVICE LINE FLOW UP SUMMIT PURPOSE & PLAN

The FLOW Up Summit aims to build a coalition of upstate New York water, public health and workforce professionals.

The New York State Environmental Facilities Corporation (EFC) mandates that municipalities receiving federal Bipartisan Infrastructure Law (BIL) funds through the Clean Water and Drinking Water State Revolving Funds (CWSRF and DWSRF) comply with MWBE/SDVOB and Prevailing Wage requirements. Additionally, 49% of BIL funding must be allocated to disadvantaged communities. However, there are no specific requirements for municipalities to implement diverse workforce inclusion plans, a key focus of the Biden Administration's Justice 40 initiative.



The FLOW Up Summit will generate a regional plan to help upstate cities meet BIL requirements while developing strategies to replace lead service lines through inclusive recruitment within local plumbing and construction trades. The outcomes will be compiled into a best practices report and presented to policymakers in Albany, demonstrating how upstate cities are effectively enhancing economic growth and capacity by prioritizing diverse workforce strategies for lead service line replacement.

These results should encourage ECF to create a rubric for rewarding cities that are growing their economy and workforce while meeting the EPA lead and copper rule requirements.

LEAD SERVICE LINE FLOW UP SUMMIT KEYNOTE SPEAKERS

Oluwole A. (OJ) McFoy, PE

Chair, Buffalo Water Board & General Manager, Buffalo Sewer Authority A Native of Buffalo, NY, McFoy was educated in the Buffalo Public School system, and is a 1993 graduate of Hutchinson Central Technical High School. McFoy is a graduate of Clarkson University with a Bachelors of Science Degree in Civil Engineering. He is a licensed Professional Engineer in the State of New York, bringing over 20 years of executive leadership, program management, and infrastructure design experience to regional water quality initiatives. Joining the Buffalo Sewer Authority as Chief Operating Officer in 2006, McFoy has also held positions of Chief Engineer,

responsible for executing the 20 year commitment to minimize the effects of combined sewer overflows on local waterways, and Chief Financial Officer, charged with managing the Authority's bonds, investments and annual budget. In 2007, McFoy was appointed Chairman of the Buffalo Water Board by Mayor Byron W. Brown, and continues to serve in this role. McFoy serves as the New York Water and Environment Association's representative to the Water Environment Federation House of Delegates, on the US Water Alliance's Water Equity Taskforce, and was recently elected to the Board of the National Association of Clean Water Agencies.

Richard Diaz

Regional Field Manager for Water Infrastructure at the BlueGreen Alliance

Being from Milwaukee, WI, Diaz strives to fight for racial and economic justice for black, brown, and working class people everywhere. Within his 10-years as a community organizer, Diaz has been able to help create Milwaukee neighborhood association Amani United, increase member participation and achieve worker oriented contracts for members of the Amalgamated Transit Union local 998, help thousands of voter's register and get out to vote, and also co-found the Coalition on Lead Emergency (COLE). His experience in building relationships, increasing civic participation, and advocacy efforts amongst marginalized groups, has resulted in numerous policy changes, newly elected officials, and partnerships between advocacy based and serviced based non-profits.

April N.M. Baskin

Chair, Erie County Legislature, NYS Senate-elect 63rd District

As a Buffalo native April N. M. Baskin is a devoted community advocate for equity and social justice. In 2017 April was elected to represent District 2 of the Erie County Legislature. District 2 is the most diverse district in Erie County, as it contains the region's wealthiest and poorest neighborhoods, as well as being home to immigrants and refugees from dozens of nations from around the world. Immediately upon taking office Baskin was selected to serve as the Majority Leader. A year later, her colleagues elected her Chairperson of the Legislature in spring 2019, making her the youngest person and the first freshman to serve as Chairperson in the history of the Erie County Legislature. She was re-elected to serve as Chairwoman in 2020 through present day. Public Heath and Environmental Justice victories include: author and sponsor of the local law establishing an Office of Health Equity ("OHE") within the Erie County Health Department. Legislative Sponsor, Erie County American Axle Plant Community Advisory Board; Policy Architect, Erie County 'Lead it Go' Program; Legislative Advocate, Call for Erie County Cancer Cluster Funding.


